PREFACE

On November 27, 2015 REDD+ held its second board meeting. One of the main points that was to be addressed at that meeting was the acceptance of the AWP (Annual Work Plan) 2016. However, the Project Board did not accept the AWP 2016 but requested that the document be revised and re-presented.

The approval of the AWP 2016 is crucial to the progress of the Project. Therefore, the adjustment to the document needed to be done as quickly as possible so that the follow up Project board meeting could be held.

The follow up meeting was then scheduled for February 5, 2016. The objectives of the meeting were:

- To review the results / progresses made since the last PB meeting.
- Present the draft TOR Project board document and modify if necessary.
- Discussion of the three Pillars (chapters) of AWP 2016 and its adoption.

One of the highlights of the meeting was that the Project board accepted the revised AWP 2016 and thus it was adopted.

REDD+ was given the go ahead to proceed with the activities suggested on the AWP 2016.

It was unanimously decided by the Project Board that the follow up meeting be held on the 22 April, 2016. The purpose of that meeting would be to measure the progresses that are made in accordance with the AWP 2016.

PROCEEDINGS

INTRODUCTION

The meeting commenced with welcoming remarks and housekeeping rules by Mr. Jerrel Pinas. A brief overview of the objectives of the meeting was given. The objectives were:

- To review the results / progresses made since the last PB meeting.
- Present the draft TOR Project board document and modify if necessary.
- Discussion of the three Pillars (chapters) of AWP 2016 and its adoption.

The meeting was then chaired by Mr. Cedric Nelom, General Director of the NIMOS. He invited all to review the program. He then proceeded the agenda. First on the agenda were announcements. There were no announcements to be made.

This was followed by introductions of all members present.

INTRODUCTION OF THE TOR PROJECT BOARD DOCUMENT

Mr. Cedric Nelom gave the TOR Project Board Presentation¹. He explained the TOR Project Board document² is a draft document and also a work in progress. The Project Board requested that adjustments be made to items IV and V of the TOR Project Board. The following were recommended:

- Item IV (Day to Day management) – the decisions made by the Project Board should not be overridden by the day to day management.
- Item V (Quorum) - it would be best to state that the meeting can proceed once a minimum of 16 members are present.

REVIEW OF THE DELIVERABLES OF PREVIOUS PB MEETING

The review of the results and progress of the last PB meeting was done by Ms. Madhawi Ramdin. In the presentation (Examination of the Results from the Project Board meeting dated 27 November, 2015)³ the agreements made at the previous meeting were mentioned and how these agreements were met. The evidence of the deliverables were documented. These documents are:

- The Revised AWP 2016
- TOR Project board.
- Project Review Report.

The Project Board received electronic copies of these documents two weeks prior to the meeting and hard copies were made available at the meeting itself.

The last *Project Board Meeting Minutes* was included in the electronic copies that was sent out prior to the current meeting but it was not brought to the table. Therefore, it was recommended that for future meetings minutes are tabled and be the first agenda item to be discussed.

INTRODUCTION OF THE AWP 2016

Ms. Ramdin introduced the AWP 2016 by way of a presentation (Introduction to AWP 2016)⁷. In this presentation an overview was given, project milestones and planned expenditures were highlighted.

Funds earmarked for the project are 2 million US\$. The estimated expenditures for 2016 is approximately 1.9 million US\$.

DISCUSSION OF THE PILLARS MAKING UP THE AWP 2016

The discussion of the three chapters for AWP 2016 was next. It was done in three parts, namely:

- AWP 2016 Pillar I⁴ – Human capacities and stakeholder engagement REDD+ Strategy
- AWP 2016 Pillar II⁵ - REDD+ strategy
- AWP 2016 Pillar III⁶ – Implementation framework and tools.

Many questions were asked with regards to pillar III.

QUESTION AND ANSWER

Q: What are the components of the NFMS?

A: It is a multipurpose / multifunctional tool that provides various forestry information. This system can give and accept forestry information.

Q: Would this system provide insight into the causes/ reasons behind deforestation?

A: The system would provide an overview of how it was before and what it now. For example: it can show that the deforestation was as a result of agriculture, mining, infrastructure etc.

Q: What are the consequences (fines, warning) incurred if deforestation occurs in a protected area?

A: These matters are not looked into as yet but as the project develops and commitments are made it would be the responsibility of all to ensure that our yes means yes. The government will have to make legislations to deal with these issues.

Q: Can illegal activities be tracked by the NFMS?

A: The REDD+ assistant can help in this regard since they are in the field.

Q: Would you work with local stakeholders in the development of the NFMS?

A: Yes. The intention is to conduct a training in August, on capacity building of the indigenous communities

Q: Many people are unclear on the land rights issues and because of this it is a challenge to protect and sustain the forest. What can be done about this?

A: REDD+ cannot solve these issues but can provide instructions on what can be done and if possible identify organizations that can help. Organizations like Tropenbos and the Ministry of Regional Development can provide information.

Q: In which phase can activities be conducted that would utilize the skills of trained personnel?

- A: The project is still in its readiness phase but it is during the implementation phase when more activities are planned.
- Q: Emission will be measured only from specific areas. How does this affect the other areas involved in the NMFS?**
- A: It is not decided on as yet but it would involve much planning, new legislations etc. Whatever is to be done, will have to be in the interest of development of Suriname.
- Q: When would the project advance from the theory phase to the practical phase?**
- A: Based on the outcome of this meeting the project will be in its practical phase, i.e., the approval of AWP 2016.
- Q: Are all government ministries involved in the process? If not it would be good to include them. Does all keep track of the commitments of those already involved in the process (do they show up for the meeting etc).**
- A: Very good point, we will track who were absent and follow up as to why. Currently one additional spot is available for an additional Project Board member but we would like to request that another spot is made available for the indigenous people.
- Q: Are there other commissioner's office involve since their officers are in the field and are they aware of the problems affecting the communities?**
- A: Currently we are working closely with the Ministry of Regional Development. We accompany them when they conduct trainings.
- Q: When will the Sipaliwini training take place?**
- A: The Regional Development officers will decide and REDD+ will work along with them.
- Q: REDD+ Assistants have received ongoing training. How and why were they trained? Will the knowledge received be put to use? Are they included in the budget so that they can help the community?**
- A: Money is important but it's not all. Discussion will be held with the REDD+ Assistants on how to use the knowledge to benefit the communities. This is expected to be achieved over

the next two days. Also we would secure help from local and international consultants. After today the project will enter its practical phase.

Q: The project is failing to evolve and we have the same reports to take back to the communities. When will we go forward?

A: At the end of the meeting you will have a better out look as to what REDD+ plans to do in the future.

COMMENTS / AGREEMENTS

- Many of the issues raises will address the implementation of the AWP 2016 and the additional training scheduled for the next two days.
- The Monitor and Evaluation Unit should be implemented as quickly as possible.
- There is no need for a Day to day Board for the project, but staff members should implement the decisions of the Project board.
- International consultant should be brought on board to help with Human capacity building as soon as possible.
- The Project Board meeting minutes should be tabled and adopted. This document will be given to the Board two weeks before the scheduled Project board meeting.
- Funds are available to continue the project but many countries are competing for the resources. In order to have access to additional funds it is important to clearly document the use of received funds and to provide evidence of the results. Therefore, no need to delay the process but work hard on moving forward.

ACCEPTANCE OF THE AWP 2016 & AGREEMENT FOR THE NEXT PROJECT BOARD MEETING

The acceptance of the AWP 2016 was done by means of votes. No one objected by raising their hands. There was a 100% acceptance of the AWP 2016.

It was agreed that the date for the next project board meeting is April 22, 2016. If possible at the same venue.

MATTERS BROUGHT TO THE TABLE

- The Ministry of Public Works should be represented at the next Project Board meeting since many of their activities (roads, infrastructure, development etc.) are linked to the REDD+ project.
- Request was also made that the Ministry of Trade and industry be present for the next board meeting.
- Provide a list explaining the acronyms used in the documents.
- Each Project Board member was given a T-Shirt bearing the REDD+ logo. It was suggested that this would be the uniform worn for the project board meetings.
- It was also suggested that the acronym ITP (indigenous tribal people) be replaced with either the word indigenous or maroons depending on the circumstances, to avoid confusion.

CONCLUSION

Mr. Cedrc Nelom concluded the meeting by thanking everyone for their participation and involvement. Congratulations were in order for the milestone that was achieved; the approval of the AWP 2016.






Geprojecteerde mijlpalen - Pillaar II
